If Medicare does pay, you will refund any payments I made to you, less co-pays or deductibles.
- OPTION 2.** I want the **CHECKED SERVICES** listed above, but do not bill Medicare. You may ask to be paid now as I am responsible for payment. **I cannot appeal if Medicare is not billed.**
- OPTION 3.** I don't want the **CHECKED SERVICES** listed above. I understand with this choice I am **not** responsible for payment, and **I cannot appeal to see if Medicare would**
